Mt Catherine (1)	480,296.85/6,925,932.09	FGCE	Potentially suitable; easy access from Flinders Plum Picnic Area.
Mt Blaine (2)	480,865.83/6,926,453.32	FGCE	Potentially suitable; difficult access to cliff line from the bottom.
Cliff overhanging Flinders Plum (3)	479,946.26/6,925,805.71	FGCE	Potentially suitable; close to Flinders Plum Picnic Area.
Mt Goolman (4)	480,244.71/6,929,457.81	FGCE	Unsuitable; critical rock wallaby habitat and cultural heritage value. Also contain epiphyte forests on cliff faces.
The Den Site (5)	480,561.87/6,925,022.57	FGCE	Unsuitable; rock wallaby shelter and breeding site.
Flinders Peak/Mt Flinders Saddle (western ridge) (6)	480,854.33/6,923,645.76	FGCE	Unsuitable; critical basking habitat for rock wallabies away from FP hiking track. Also contain epiphyte forests on cliff faces.
Scott's Scrub Pinnacle (7)	482,338.40/6,923,521.95	FGCE	Potentially unsuitable; would ideally like to exclude people for dry rainforest in this area.
Flinders Peak (southern side) (8)	481,094.00/6,923,167.72	FGCE	Potentially suitable; limited evidence of rock wallabies, although Not a recognised visitor area. Contains existing site known as the "Secret Cave" at 481034/6923523.
The Bommy (9)	481,625.79/6,924,399.27	FGCE	Potentially unsuitable; rock wallaby feeding habitat.
Existing site (Flinders Peak) (10)	152.80912/-27.80443	FGCE	Unknown; never been to this area. Potential for rock wallabies.
